Part of Social Alley, a long hallway full of relaxing and comfortable seating, the Senior Lounge is a spot for seniors to socialize, meet, start up a game of Mahjong or bridge, or simply enjoy a calming atmosphere. Gateway Center is also home to a ballroom, state-of-the-art catering kitchen, fitness room, and classrooms.

Message from the City Manager

By now, most of our residents know that the Building Department initiated a Special Inspection Program at the end of June in response to the Surfside building collapse. This program allows our Building Department to assess each property built before 1982 and uncover any unexpected issues. Just as important, it gives residents peace of mind that they are safe in their home.

Some of you have questioned where the year 1982 came from. Miami-Dade County has a 40-year recertification process in place that requires buildings to undergo an inspection when they become 40 years old, and subsequently every 10 years after. This process involves buildings hiring an architect or engineer to perform structural and electrical inspections, and then submitting a report to our Building Department. If repairs are required, the building must hire a Florida licensed general contractor, obtain the necessary permits, receive final approval from our inspectors, and submit a final certification letter from their architect or engineer of record in order to receive certification. In the rare case that a building is deemed non-compliant with the 40-year recertification process, our Building Official may be required to refer them to the Miami-Dade County Unsafe Structures Board, a quasi-judicial advisory committee that reviews the decision of Building Officials regarding buildings considered unsafe.

Our goal in initiating the Special Inspection Program was to take a proactive approach to inspecting all buildings nearing their 40+ year recertifications and those that already had theirs. There are 59 buildings that meet the criteria of this program and thus far, the Building Department has completed the assessment of 19 buildings. But just because a building's special inspection is complete does not mean the building is automatically in the all-clear. If our inspectors find a concern or something unexpected, they will require the building to contract a Florida licensed professional engineer for further evaluation. Buildings will have 30 days from the date of notice to submit the engineer's report to our Building Department.

As a result of these inspections, the parking garage of one building was partially declared unsafe by the engineer doing the garage repair design, due to deterioration that required immediate attention. The condominium's pool, located on the second floor of the parking garage, was drained and 150 cars were required to relocate. The City is assisting with providing alternate parking for those residents. To reassure residents, now that the garage is partially empty and installation of additional shoring has taken place, the engineer has declared the building safe for continued occupancy while the repair work is ongoing. But this is a good example of how our



inspections are proactively helping mitigate risk.

At the July Commission Meeting, John Pistorino, a professional engineer, spoke about the methodology of high-rise construction and explained how he wrote the requirements to create the 40-year recertification back in the 1970s. He explained that for the buildings built recently, the strength of the concrete and construction is greater than it was 40 years ago and that these buildings also have multiple safeguards in place to make sure they are safe to live in. There is also the State of Florida Threshold Building Law, which requires any building with more than three stories to have an independent engineer inspect and certify that every constructional component is in accordance with the building's plans. John also pointed out that the intention of the recertification process isn't that condos should wait until the building is 40 years old to look at it. They need to take a proactive approach rather than waiting for issues to arise. We live in a hostile environmental zone due to the high concentration of salt in the air, but if you catch an issue early enough, it can be handled in a reasonable and inexpensive fashion. To put it plainly, as long as the building is being looked after, it will be safe for residents.

We post the status of the Special Inspection Program regularly on our website at <u>sibfl.net/specialinspections</u>. You can see which buildings are undergoing inspections and whether the inspection is pending or completed. Residents should inquire with their condominium or building management office to find out if a notice was issued and to obtain a copy if that is the case.

We understand and are doing everything in our power to ensure that your condominiums and buildings are all safe. This process takes time and we appreciate your patience as our Building Department works tirelessly to complete these inspections in addition to their regular day-to-day tasks.

The Surfside Collapse and the Inevitability of Change

The Surfside collapse is a tragedy without precedent in our coastal communities. The loss to our neighboring Surfside community is both immense and incalculable. Over time, Surfside will likely be viewed as a watershed moment. It's a turning point in how we address building inspection, reinspection, maintenance protocols and oversight along multiple lines. While the causation(s) of this collapse remain unidentified, the inquiry into the life safety of our coastal high-rise buildings is in full throttle.

Miami-Dade County and our city have been fully immersed in 40+ year old building inspections. Miami-Dade's grand jury, the Florida Bar's Condominium Law and Policy on Life Safety Tax Force and several Florida engineering boards amongst others have been tasked with examining this event, the efficacy of our inspection requirements and procedures, condominium law and association operations, and providing recommendations for



legislative and/or regulatory changes.

For many years I have stood for greater transparency and accountability in our condominium associations. Every unit owner should have access to the records of their building condition. Boards should be responsive to their members regarding their building needs. Increased resident awareness and participation is also a cornerstone of condo reform. I will be conducting future condo rights workshops exploring these many issues and welcome your input.



NEW BUILDING PERMIT FEES

We would like to commend the Building Department on successfully developing a new building permit fee structure. After a comprehensive analysis conducted by JRD & Associates, the new fee structure is more transparent, concise, easy to understand, and will ensure cost recovery. The most notable part of the revised building permit fees is that they are more economical for our residents completing small projects. Residents wishing to complete a \$5,000 project can now expect a 78% reduced permit fee. In addition, our fees for commercial projects remain competitive when compared to neighboring cities.

The new building permit fee structure is as follows:

Take the total cost of your job or project and multiply it by the percentage in the appropriate tier below to figure out the cost of your building permit.

RESIDENTIAL FEES

Minimum fee: \$25 applied to the job value up to \$1,000.

Tier 1: Job value between \$1,000 and \$50,000. 2.75% of Job Value

Tier 2: Job value between \$50,000 and \$100,000. 2.50% of Job Value

Tier 3: Job value exceeding \$100,000. 2.00% of Job Value

COMMERCIAL FEES

Minimum fee: \$25 applied to the job value up to \$1,000.

Tier 1: Job value between \$1,000 and \$100,000. 2.75% of Job Value

Tier 2: Job value between \$100,000 and \$1,000,000. 2.50% of Job Value

Tier 3: Job value between \$1,000,000 and \$100,000,000 2.00% of Job Value.

Tier 4: Job value exceeding \$100,000,000. 0.50% of Job Value

Note: The new building permit fee for new constructions and additions includes roofing, windows/doors, driveway (not including approach), and zoning (the plan review). The new permit fee structure is proposed to start in October 2021 to coincide with our new fiscal year.

SCHOOL

TRAFFIC Safety

The City of Sunny Isles Beach also has a zerotolerance traffic enforcement safety initiative. Please obey all traffic rules, be alert of oncoming traffic when crossing the street, and yield to pedestrians. When loading or dropping off students from school, use the designated drop-off lane and have students exit/enter the vehicle from the passenger side only.

If your student rides a bike or skateboard to school, make sure they are wearing the right protective gear, following the rules of the road, stopping at stop signs and always looking both ways before crossing a street. Students may bring their own lock and secure their bike at the racks adjacent to the P.E. shelter or secure your skateboard at the racks located at the 181 Drive / North Bay Road bus stop intersection.
